- 2.190,00 euro will be paid after the completion of the second training, at the completion of the day study and at the completion of the competition among students on conducting the best research papers on the death penalty in Palestine.

The payment of the second and the third installments can be realized only upon a delivery of request payment sent by the Faculty of Law/ Arab American University of Jenin.

1. Background

Capital punishment is not banned by international law; however, It does put binding restrictions on the implementation of it, and it encourages states to repeal it. Many human rights organizations revoke death penalty as it is seen as a degrading punishment which violates human rights conventions.

The legislation system in Palestine is derived from legislations of nations who ruled Palestine for many decades beginning of the Ottoman Empire (1516-1922) until the establishment of the Palestinian Authority in 1994. Most of these laws and rules do not harmonize with international human rights and conventions including the revocation of capital punishment.

The Palestinian Authority death penalty laws are based on the Jordanian law (in the West Bank) and the Egyptian law (in Gaza strip). The Most prominent legislations are the penal law No. 74/1936 acted in Gaza Strip, the Jordanian Penal law No. 16/1960 acted in the West Bank and the PLO revolutionary penal code, of 1979. However, all of these laws legislate violation of human rights particularly the right to life through legalizing death penalty.

Since the establishment of the Palestinian Authority until the election of the parliament in 1996 many people have been legally executed. The execution of the death penalty in Palestine is urged to be reconsidered in light of the recent legal developments concerning the legal status of the state of Palestine and joining many international human rights conventions since 2014. Accordingly, these laws should be replaced with laws pursuant to the International Human Rights Laws and Conventions

2. Objectives and Goals:

The activities are aimed at conducting debates between university students on the most controversial topic; which is the death penalty. Palestinian society is divided intellectually, politically, philosophically, and empirically between implementing or abolishing the death penalty. Furthermore, international experts in favor of abolishing death penalty will enrich the debate by sharing their opinions. Moreover, a comparative law between Palestine and other countries will be addressed in the debates.

The first stage

The first seminar: Judicial guarantees in the application of the death penalty under Palestinian legislation The second seminar: The death penalty in the light of international conventions on human rights and Palestinian legislation

The second stage

A workshop will be organized hosting domestic and international experts supporting the abolishment of death penalty. They will look at different cases of countries where death penalty was legally abolished.

The third stage

The best research paper on the death penalty will be awarded a prize that will be chosen by an internal commission.

3. Methodology

As indicated by the AICS, the activities will be held in the academic year of 2016/2017. Three meetings will be held in three months February, March and May 2017.

The entire program will be in Arabic and English.

The activities will be dedicated to the development of three components divided in the following models: 1. The first stage will be devoted to acquire knowledge of death penalty rules and standards included in the conventions executed by Palestinian Authority.

2. The second stage will focus on right to life and the abolishment of death penalty.

3. The third stage will be dedicated to choosing the best research paper on death penalty.

The methodology of the activities will be interactive, participatory and built on the participants' experience. The activities will provide case-based opportunity for learning. Plenary discussion, brainstorming, working in pairs and group work would be used so that activities could offer a "Learning by Doing" methodology.

4. The final report

At the end of every meeting two reports should be submitted to the AICS: The first report will reflect the nature of the activities that were conducted, the participants involvement and interaction, a follow-up plan for future activities on the subject matter.

The second report will be a financial report.
